

I ask that the LTC not proceed with this application. Please do not go to a public hearing. This issue has been well publicized and addressed. The OCP review recently concluded that no change be made to the existing RLUB rule on public docks. There have been public meetings on this issue. A well organized campaign of support has been completed . What,s the issue? An illegal dock in place.

What's the process? Refer the issue of private docks to the APC for their comment and consideration of a change to the existing OCP policy.

Consider the recommendations of the Islands Trust Staff report.

Further public consideration of this specific application will only deepen public division. Participation will be one sided, as no one in opposition wants to be yelled at in a public meeting, subject to intimidation, or threatened.

Had the applicant followed the legal process and applied before building the dock, I would have had little to say. For me the issue is the attempt to subvert the Community plan, ignore the RLUB, and undermine the legitimacy of the Islands trust. We either rule by laws agreed to by the majority of participants, or we rule by who shouts loudest and musters the most support on each issue. I favour rule by law, with opportunities for dissenters to appeal.

. While the applicants offer of emergency access is laudable, having driven the EMU for 10 years, I cannot imagine driving an injured or ill person down that slope, nor do i think that the vehicle would make it back up. The dock at the Lasqueti Fish company is a viable deep water alternative for emergency evacuations. Only the Laqueti First responders can identify how often, if ever, there has been a medivac in Scotty Bay. Most medivacs occur either at False Bay dock or by helivac at the school.

Happily I,m told there is an alternative solution that could allow the applicants to keep their dock and provide a public good in exchange. If a public dock were constructed at the Scotty Bay public access by the applicant, the LTC could legalize their dock. There would need to be a rezone of the foreshore, approval from the Feds, and an agreement with Qrd to administer and maintain the dock(part of local services). The provision of a public good in return for a variance of the local bylaws is well established provincially. I suggest the LTC consider legalizing the existing dock in return for the applicants building a public dock in Scotty Bay.

We appreciate the opportunity to comment on this application. We believe that the Lasqueti Trust Committee should make its decision on this application based on two important principles.

Firstly, the Lasqueti Trust Committee should base its decision on the policies and regulations contained in the Lasqueti Island OCP and Land Use Bylaws, as well as the Islands Trust Policy Statement and relevant Provincial and Federal legislation. In particular, the Lasqueti OCP and Land Use Bylaws represent the vision of the community for land use and development on Lasqueti Island and surrounding waters. These documents have been developed after extensive consultation within the community. It is a principle of good governance to make decisions that are in keeping with the contents of these documents.

Secondly, we believe the Lasqueti Trust Committee should base its decision on the principle that all persons who make an application for a re-zoning or other form of permit have a right to fair and equal treatment, regardless of who they are. The decision should be based on objective consideration of the merits of the application, not on the applicant's relationship to or history in the community.

The Lasqueti Island Trustees have been elected by the community and entrusted with the responsibility to make decisions. Whatever decision is made, as long as that decision is clearly based on respect for the relevant community-based policies and the principle of objective fairness, we hope that all members of the community will respect the Trust Committee's decision as fair and reasonable.

The Lasqueti Trust Committee has a significant challenge in determining how to proceed with this proposed rezone to exclude this property and its unpermitted dock within the Land Use Bylaw (LUB). The Lasqueti community developed the Official Community Plan with its stated goals based on NOT being a transient or commuter community. The two days a week we have no ferry reflects this overall goal. The OCP was reviewed by the public in 2019, and these marine zones and restrictions remain. However, there has been considerable support for the particular people who have installed this dock, while there is also considerable objection to going against the community's vision and wishes, reflected in the OCP and legally outlined in the LUB.

The Carey's property, Lot 62, was purchased and developed from a forested property to a recreational home in 2019/20, including building a home and driveway leading from (Conn Road) down to the foreshore, including the installation of cement blocks in the intertidal area and a dock.

- The owners were made aware that the Community's Official Community Plan and Land Use Bylaws prohibit docks in areas with public road access by trustees, our regional director and Islands Trust staff. Nonetheless they went ahead and built it. After being initially turned down, they are now again asking for approval based on offering a public benefit.
- If approved, it will likely set a precedent for future applications for private docks. Just in Scottie Bay alone, there could be several other lots where waterfront owners could apply for a private dock. The acceptance and proliferation of waterfront owner's docks would open the door to a different type of community, impacting the foreshore, surrounding environment, and neighbouring islander's property taxes, peace and tranquility.
- With all the moorings and boats currently in Scottie bay, there is very little room for a passing or
 visiting boater to take safe anchorage in the only all weather bay off the Island. The applicant's
 dock takes up some of that room, including for boaters with twin keels who can sit on tidal
 lands (such as Brent Swain, who often anchored in the dock's current location. Brent installed
 the large marker at the head of the bay marking that hidden reef to help boaters safely pass
 into the bay.)

The Islands Trust LTC seems to be considering acceptance of this non-conforming dock, subject to public benefit being given to the community by the owners. The owners have proposed this benefit as occasional emergency access through placing a statutory right-of-way across their property in Scottie Bay to their dock for emergency purposes. Despite the long-term legal and cost implications of the Careys' offer, the LIVFD and the Qathet Regional District, and other emergency services provided by the Province will likely be unable or need to use the Careys' dock, for several reasons.

- 1. The Cape Class SAR boats used by the Coast Guard at French Creek to evacuate people off the island in an emergency have a draft of 1.4m and a length of 14.6m. It may not be possible for an evacuation at low tides or any tide at this location.
- 2. The ramp from shore to the Carey's float may be to narrow for four First Responders to carry a stretcher. The new private driveway that connects Conn Road to the dock may be too steep for the ambulance.
- 3. The LIVFD doesn't need permission to cross private property and doesn't need a legal right-of-way in the event of an emergency.
- 4. The extensive docks owned by the Lasqueti Fish Company are far more accessible for emergency use in Scottie Bay.

The Careys' current offer doesn't seem viable, and doesn't meet the threshold for providing public benefit. However, there is no doubt that the Lasqueti community could use more public dock space. The dingy dock at the end of the public access road in Scottie Bay, which was removed a few years ago, allowed the owners of the 18 boats currently moored in the bay safe public access to shore. Karl's study of safe dock locations identifies Scottie Bay as one of the best places on the island for a dock. A safe dingy or larger public dock, built to standards and set adjacent to the existing public road access would provide real long-term community benefits. A public dock in the bay would:

- take transit boating pressure off the Lasqueti Fish Company dock;
- provide a safe access to shore for locals and visitors who moor their boats in Scottie Bay;
- allow the Careys to keep their dock (without further extensions of the float).

If the Careys offered to build and install a public dock at the existing public road access site in Scottie Bay in exchange for approval of their existing non conforming dock they would be providing a considerable public benefit to the Lasqueti community. Once completed and installed, the the dock could be transferred to the Qathet Regional District (or other public body) similar to the public ramp in False Bay. The Islands Trust could then complete approval of this application.

Although this would be costly to the applicants, it would eliminate costs resulting from legal action for this bylaw infraction, including removal of the dock and any remediation required. Instead, the Careys would be receiving legal access to use crown/public land, adding substantially to the value of their property.

The community needs a safe public dock in Scottie Bay, and this proposal may provide a one-time exclusion that does not set a precedent for future private docks.

Dear Islands Trust members and Trustees,

I am writing this letter in support of John and Tracy Carey's application to allow their private dock in Scotty Bay. I have been a part- and full-time resident of Lasqueti since I was born, in 1960, and my family owns the other private dock in the bay under Lasqueti Marine Storage. Scotty bay is basically the only safe and secure moorage on the island, False Bay is exactly that, the southwest, "Qualicum" wind comes straight into the bay with very large waves and can do a lot of damage to both docks and boats. The floats are already oversubscribed, adding more boats tobe moored to the floats or wharf is ridiculous. Private docks and floats in protected areas that have had a favorable environmental impact study, should be encouraged, not discouraged for a number of reasons.

- 1-Safety, the ability to remove patients of an emergency situation in that area, or if the main dock is full, which it usually is when the ferry comes in.
- 2-Next would be ferry issues. Unreliable service and overcrowding are real problems, having people with their own boats frees up more room on a already overcrowded ferry.
- 3- Fuel has been an issue recently on Lasqueti as there is no weekly barge service, especially in the winter when residents need fuel the most as solar is a minimum. Some residents with their own boats transport fuel for themselves or others, while fuel is not allowed on the ferry, is it mostly unloaded at the public dock, which isn't' a desirable option if there is an alternative.
- 4- The Carey's did a proper and professional job with the necessary DFO environmental impact studies, which were all favorable, bought a proper high-end dock and ramp that was installed with minimum impact to the seabed.

There are many people that use our private dock without our knowledge or permission, despite signs stating the fact it's private and trespassing isn't allowed, I would have to say that Lasqueti is in need of more docks, not less, and can see absolutely no reason why this application would not be approved.

I am writing to express my Support for the Carey's Dock in Scotty Bay, Lasqueti Island. I have watched this project since its infancy. Because there is such a shortage of secure protected dock space on this island I can't say enough about the importance of having this dock at that location.

I remember when I first started coming to Lasqueti Island by sailboat. The charts indicated that there was a public access in Scotty Bay at the end of the road that passes by the Livingston residents. Today on the charts that access no longer exists. In fact there appears to be no public access in Scotty Bay whatsoever! As this is the only sheltered Bay with deep water access on the North East side of the island it seems ridiculous for so many reasons. People say "just use the Lasqueti Fish Company Dock", but that is PRIVATE PROPERTY! In no way is it right for people to think that just because it exists in that location that they should be allowed to use it; just like any other PRIVATE PROPERTY on the island. LFCo. is running a business there and no one should be TRESPASSING with or without the owner's "permission" as the legal liability for them must be huge. I have witnessed a number of people take advantage of LFCo. in this manner and I have heard of a few who have been hurt by falling on a slippery dock. Lasqueti Trust Committee:

Please accept this submission in respect of Application LA-RZ-2023.1-LTC, seeking approval of an unlawful dock in Scottie Bay, which I understand will be considered at the trust committee meeting March 4, 2024.

My wife and I are recreational property owners on Lasqueti, having decided to purchase in this pristine area over 30 years ago. Our primary motivation for purchasing was our concern respecting overdevelopment of the waterfront which we observed elsewhere on the coast.

I am opposed to the application. I have read the relevant staff report, and I am in full agreement with the reasoning and recommendation in the report.

There are numerous reasons for my opposition to the application, most of which are dealt with in the report, however, I will address two in particular.

PRECEDENT

To prove this application would set a terrible precedent. There are no special circumstances involved with this application. The applicant has chosen, for his own convenience, to build a dock and trespass on crown land in contravention of the Lasqueti zoning bylaw. If his action is condoned, it is only fair that similar actions on the part of others should also be condoned. Consequently, selfish and self interested people benefit, to the detriment of the public interest.

EFFECTIVE PRIVATIZATION

Again, if the applicant can have a dock where there are no special circumstances, excepting his willingness to defy the law, then it is reasonable that all other waterfront owners can do the same. This is likely inappropriate for environmental and aesthetic reasons, but it also has significant social consequences. Docks take up public spaces, otherwise available to members of the community and transient boaters. Initially, the impact is slight, but as the docks proliferate, the former welcoming public space is effectively privatized. Anyone familiar with the coast can point out dozens of places this has happened over the last 40 years.

I urge you to reject this application in the public interest.

I would like my opinion to be included as support and form part of the official record regarding application number LA-RZ-2023.1-LTC.

In regard to the above Dock Application, I would like to add some history:

Our family lived on Texada Island and I have been coming to Scottie Bay for in excess of 65 years. Scottie Bay is one of the very few protected harbours on Lasqueti Island. As with many protected bays on this coast with a very long history, many relics no longer "treasured" found their way to the ocean.

I have included some pictures of part of these discarded items:









As part of the dock construction, Tracee and John Carey, in typical, thorough fashion, cleaned up many of these items from the adjacent area and removed them from the foreshore. What is unseen here in the attached photos is a variety of other discarded "treasures". I was personally involved in removing two sunken boats, one engine block,

part of a broken toilet, several broken lengths of sewer pipe, 3-4 broken cast iron parts from a stove, and -OH YES-2 bicycle frames. These items including the old "float house?", a rotten grid and 3 other wrecked boats have all been removed from the foreshore and made a significant contribution to the beauty of Scottie Bay.

I would suggest that it would be a wonderful idea to carry forward with the momentum that the Careys have started as there are several glaring examples of what can be done elsewhere in the bay. The influx of people frequenting lasqueti, including summer visitors, year round holiday visitors, tourists, combined with the existing local population (a growing population) that use the ferry on a regular basis, continues to push the safety parameters of what the False Bay dock and surrounding area can safely handle.

The more traffic, the more chaos, the more likely someone is going to be hurt or worse yet killed.

Aslan's dock as well as other privately owned docks, take some of the pressure off the False Bay Area.

For example, one weekend last summer, I counted over 50 people that used mine (Lasqueti Fish) and Aslan's private docks, that would otherwise have added extra congestion/strain to False Bay. The Carey's dock is a tremendous asset to the island for many of the following reasons;

The ferry service is inadequate of supporting the amount of volume of traffic and cargo during peak season and, does not provide 7 day a week service. Relying on the ferry has proven impossible and on countless occasions necessitated the requirement of using private boats to get off and on the island.

There is no space available to tie up a private boat in False Bays or Squitty Bays Government public docks as they are already over capacity. The geography of Lasqueti Island provides little protection from weather for safe harbour for moorage and docks as the majority of the islands shores are exposed. Scotty Bay is the only option for then north west side of the island for a safe and protected dock. The other existing dock in Scotty Bay is a Private/Commercial dock that is at capacity with commercial fishing vessels, nets, and equipment occupying space on the dock.
