#### Lasqueti Island Ferry Service Survey

#### **Summary of Results and Recommendations**

The Lasqueti Community Association ferry committee conducted a ferry service survey in Aug 2019.

The following recommendations/requests are supported by the survey results:

- 1. Include the ability to buy same-day return passes on the ferry (i.e. when paying fares on board the ferry for a day trip to/from Lasqueti, to increase certainty of being able to get on a return run the same day). [question 17]
- 2. Continue providing an extra run when 10 or more people are left behind on the last run of the day, but also request the ferry operator to work with, and potentially subcontract, a local water taxi when 1-9 people are left behind on the last run of the day. [question 20]
- 3. Improve boarding pass system and consider pre-paid ticket booklets. [questions 16 & 22]
- 4. Consider implementing reduced fares on less busy runs (for example, reduced fares on Saturdays, or additional discount days for seniors or families) to encourage a better distribution between busy and less busy runs. [question 23]
- 5. Require the service to participate in the Travel Assistance Program (TAP). [question 25]
- 6. Provide reduced fares for travellers with disabilities and their assistants who need such assistance to be able to travel, especially on the ferry. [question 26]
- 7. Encourage a more active role by the crew in loading/unloading (e.g. ensuring passengers on busy runs stow freight efficiently and safely) [comments associated with question 28]
- 8. Ensure there is emergency equipment on the ferry that is appropriate for the long crossing (e.g. AED/defibrillator and EpiPens) [comments associated with guestion 29]
- 9. Seek ways to reduce use of fossil fuels used by the service. [guestion 31]
- 10. Ensure public consultation by BC Ferries and/or the Ministry of Transportation and Infrastructure regarding important issues and key changes to the Lasgueti ferry service (including service renewal).

There were 273 responses (254 online; 19 on paper). The following summarizes the number and percentage of responses, excluding non-responses to questions. Further details are provided when responses were mixed, when the majority wish for changes to the service, or for further clarification.

## Ferry Days and Number of Runs

10. Are you satisfied with the current number of ferry runs?

Notes: Overall, 54% want the same number or fewer runs compared with 46% that would like more runs. A strong majority do not want fewer runs (i.e. want the same number or more runs).

There is a difference between responses from full-time and seasonal residents:

- 40% of full-time residents want more runs (72 responses with "more"), and 60% do not want more runs (107 responses with "satisfied" or "fewer")
- 57% of seasonal residents want more runs (49 responses with "more"), and 43% do not want more runs (37 responses with "satisfied" or "fewer")

Notes: The largest responses were for people wanting more sailings on:

- Wednesdays outside of peak season (there are presently Wednesday runs during the peak season, but not in the non-peak season). The entry with the highest number of responses was for increased runs on Wednesdays in June (84 responses; 31%).
- Sundays (there are presently 2 runs/day on Sundays, compared with 3 runs/day on other ferry days)
- Tuesdays (there are presently no runs on Tuesdays; this was a common response for people who wish 7 day/week service)
- Fridays in the summer months (especially for long-weekends)

Notes: The responses to this important question were mixed. If an on-line reservation system is to be explored, further consultation and clarification of potential features and effects is needed.

There is a difference between responses from full-time and seasonal residents:

- Full-time residents: 32% want an on-line reservation system (57 responses), 47% do not want an on-line reservation system (82 responses), and 22% are unsure (40 responses)
- Seasonal residents: 77% want an on-line reservation system (67 responses), 9% do not • want an on-line reservation system (8 responses), and 14% are unsure (12 responses)

The responses to this question were also correlated with the amount of time spent/year on Lasqueti (question 5):

- 9 months or less on Lasqueti: 68% want an on-line reservation system (82 responses), • 15% do not want an on-line reservation system (18 responses), and 15% are unsure (18 responses)
- 10 months or more on Lasqueti: 28% want an on-line reservation system (42 responses), • 47% do not want an on-line reservation system (72 responses), and 22% are unsure (34 responses)

In the comments, the most common reasons in favour of an on-line reservation system were increased certainty of catching a run, decreased anxiety about missing a run, and reduced time and fossil fuel use to get passes. The most common reasons in opposition were maintaining fairness for people with little or no internet access and for people of limited financial means (if such a system cost more), and concerns about reducing the number of first-come-first served spots.

Notes: Concerns about missing the last run of the day are significant. It seems inefficient for the ferry to return (and add the time, expense and fossil fuel usage) for less than 10 people. However, there is a significant expense and difficulty for both full-time and seasonal residents if they cannot catch the last ferry of the day. A smaller boat, such as a water taxi, could fill this need.
